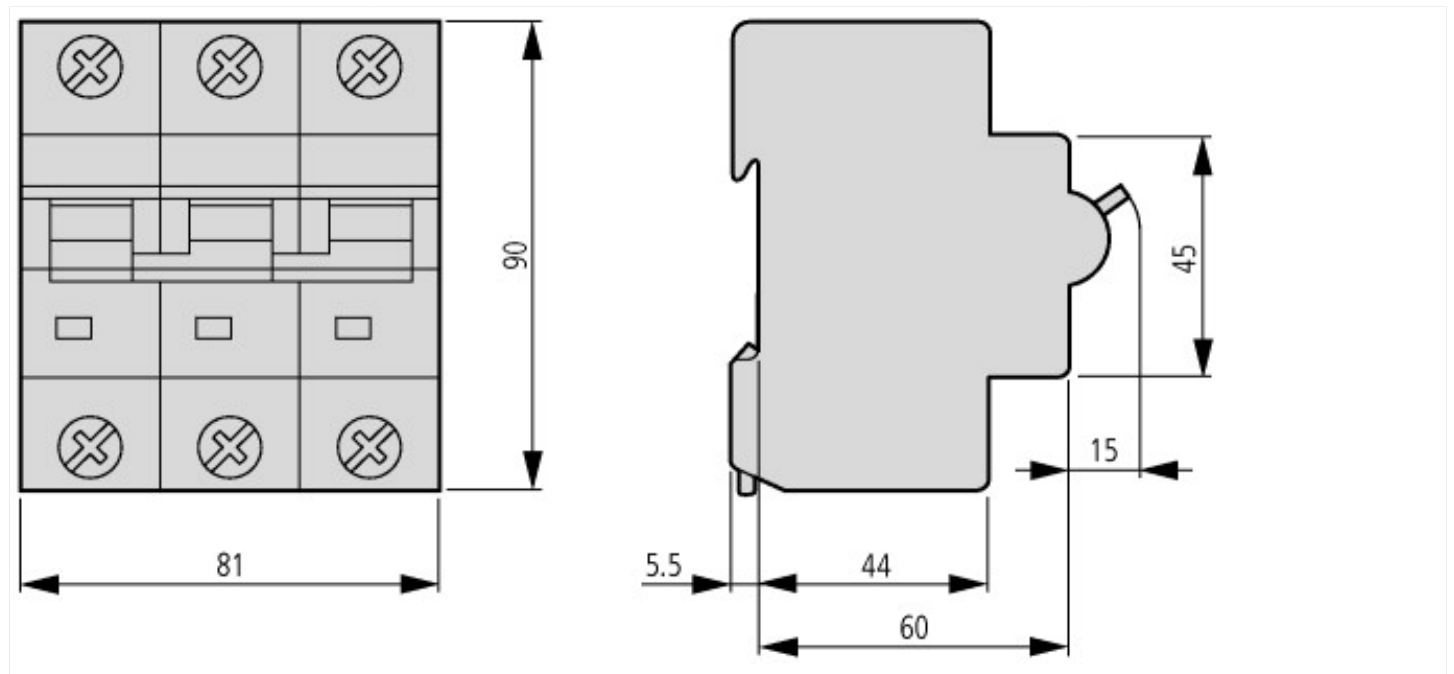
Let-through current  $i_D$
